- Must have professional leadership in the fire service as a career, volunteer, or retired Chief with five (5) or more years of service in a fire service department, listing his or her supervisor of the city, fire district, village or parish.
- **List noteworthy achievements in the fire service field as Chief:**
 - Honors
 - Citations
 - Lifesaving awards
 - Special services
 - Training courses
 - Special technical training
 - Fire organizational group and positions held
 - Educational degrees
- List memberships or service in civic organizations and community work.
- List memberships in youth work or teaching in areas such as Jr. Firefighters, scouting, church, health facilities, and others.
- List any military service achievements, including campaign metals or special decorations for meritorious service, if applicable.
- Family life, if married, Religious affiliation with his church and his spiritual walk, or growing up experiences.
- Any service of honor that he or she has.
- Finally, a statement by the person submitting the honoree recommendation, as to why this person should be considered for this honor.

Professional Achievements:

- The chief entered the Fire Department in 1963, achieving positions of firefighter, firefighter pt class, inspector, investigator, industrial training and Fire Chief of the Lafayette Fire Department which he served as chief for 10 years.
- He received two (2) lifesaving medals and awards for a small child and an adult male during his service. He was honored by the City Council for that achievement.
- During his years he attended LSU, Texas A & M, International Association of Fire Chief, National Fire Academy, Homeland Security, ATF explosive schools, management and budget training. A total of 42 different training and seminars in his professional field of work, Annual organization conferences and training.
- He received a number of other honors in his position which I have not listed because it would be too long to read at a presentation program. (You may attach an additional list, but please do not go into great depth of the achievement.)

Educational Achievements:

- Graduated from Lafayette High School, attended USL (ULL) and LUS achieving an associate degree. Completed classes with H & R Block in tax preparations, American Red Cross Water Safety, and First Aid instructors. A graduate of Red River Arsenal Military Training in explosive materials and devices. Completed courses with Pierce Manufacturing Inc. on apparatus design, operations, and maintenance. He has completed business courses which are too many to list.
- Past President of the Parish Fire Association, Louisiana Fire Chiefs, Southwestern Fire Chief Division and National Board member.

Civil and Community Organizations:

- Member of the Boy Scout of America for 68 ½ years, of that time 55 ½ years as Scoutmaster of troop# 19 sponsored by the First United Methodist Church and Beaver's Club of Lafayette. He achieved many honors and awards: An Eagle Scout; received the Silver Beaver Award, Wood Badge, plus in retirement, as Scoutmaster of 130 Eagle Scouts.
- He is a member of the Beavers club of Lafayette for 55 years and served in all positions of club officers. Served as Chairman of the American Red Cross Charter, 32th degree Mason, and Firefighter bowling team for years. A Homeland Security instructor for Violence in the worship place and served as director of Fire Academy oil field firefighting school. Member of the French Music Cajun Association. Vice Chairman of the Lafayette Fire & Police Civil Service Board and Northside Ministry Association.

Religious work:

- He was born and raised Catholic and became a member of the United Methodist Church upon marriage to his wife.
- Served in all positions in his church as officers and local, district and state President, plus served as 2nd Vice president nationwide.
